Directions to Show - Use HHP address at your own risk. Please follow these directions: From I-65 South of Indianapolis, take exit 76B (US 31/Taylorville) north 4 miles toward Edinburgh. After crossing river, at Jct SR 252 (3rd stoplight) turn left onto Old Hospital Rd (may see signs for Camp Atterbury). Go 3 miles and turn right into Johnson County Park on Schoolhouse Rd. Go 9/10 mile, turn left onto 31st St. Go past the covered arena, turn left into Compound to Barns I-J-K-L. Watch for signs. Office located next to Restrooms near Barns.

General Information

Use ADS Combined Driving entry form.

Entries are first come, first served and are prioritized by postmark beginning on entry opening date. Waiting list. Mail copy of Coggins and ADS card with entry and include email address.

Completed Safety checklist must be turned in at safety check/wheel measurement at least 15 minutes prior to dressage both Friday (CT) and Saturday (CDE).

Likewise, completed safety checklist must be turned in at safety check at least 10 minutes prior to marathon.

Navigators and Drivers may go a maximum of 2 times on course, in different divisions, only if noted on entry form and scheduling allows.

No schooling in obstacles 30 days prior to event. Slow Moving Vehicle sign required. ALL DOGS MUST BE ON LEASH.

Awards: Class prizes and ribbons to 8th place; Championship, Secretary, Poncho and Navigator awards.

RV sites filled on first entry basis. Include camping fees on entry form. Absolutely no RV, trailer, ATV or large appliances plugged into barns.

Other Information

Negative Coggins within one year of show date. Must send with entry. 30-day Health Certificate for all out-of-state entries - will be checked upon arrival.
